Intent to Option Player

(Managers must fill out the form completely, and obtain the required parental signature before submitting the form to the Player Agent.)

Upon confirmation of the Manager's approval for the current season, and after verification that all rules and regulations regarding options have been met, the Player Agent will approve this Intent to Option Player Form. The Manager will then be notified of the acceptance of the option. If an option request is denied for any allowable reason, the manager must complete a new form and submit it to the Player Agent by the end of the last official day of Player Ratings, or no new option will be allowed.
